You agree that the ECCS Home Show will be the only home show in Nassau County, New York you participate in on these dates.
- Neither ECCS nor Nassau Veterans Memorial Coliseum shall be responsible in the event that the show is cancelled or shortened or the dates changed due to inclement weather, acts of God or nature, acts of war or any other reason whatsoever.
- ECCS will not be obliged to refund any part of the exhibit fee should Exhibitor cancel for any reason after signing Exhibitor Agreement. No Exhibitor who is not paid in full by Oct. 1, 2018 shall be permitted to pay in full on the date of the exhibit and will also be held liable for any outstanding balance. ECCS is authorized to collect payment with credit card on file for balances due if not paid by due date.
- Exhibitor shall and does agree to indemnify, defend and hold ECCS and Nassau Veterans Memorial Coliseum, their successors and assigns harmless for any and all liability for damage to property or injury to persons resulting from or arising out of the operation of the Exhibitor's business or booth pursuant to this agreement including the setting up and dismantling of the exhibits, and supply certificate of liability insurance for no less than one million dollars.
